



Terms and Conditions – *Get a donation to win promotion*

Eligibility Period:

- Starts **00:01 AEST on Monday, 1 December 2025** and ends at **23:59 AEST on Friday, 5 December 2025**

How It Works:

- Receive a donation to a 2026 International Women's Day Fun Run event fundraising page via the official website www.womensdayfunrun.com.au
- Ensure the donation receives a donation receipt.
- Each donation of any amount will be one entry into the draw.

Notifications:

- Mater Foundation will contact the winners within 5 days of the draw date.
- Details of the winner will be published on www.womensdayfunrun.com.au following the draw.

1. Entry into the International Women's Day Fun Run 2026 (IWDFR) ***Get a donation to win promotion*** ("**Promotion**") is deemed to be an acceptance of these Conditions of Entry. Information on how to enter the Promotion and prizes associated with the Promotion form part of these Conditions of Entry.
