



Terms and Conditions – *Fit to Fab* promotion – Queensland Residents only

Eligibility Period:

- Starts **00:01 AEST on Monday, 23 February 2026** and ends at **23:59 AEST on Sunday, 1 March 2026**

How It Works:

- The Promotion is open to eligible participants who fundraise for the **2026 International Women's Day Fun Run** via an individual fundraising page hosted at <https://www.womensdayfunrun.com.au>.
- During the Promotion Period, entrants will receive **one (1) entry into the prize draw for each fundraising milestone achieved** on their individual fundraising page.
- **Fundraising milestones and corresponding entries are:**
 - \$150 Fundraising milestone reached** = 1 entry
 - \$500 Fundraising milestone reached** = 1 additional entry
 - \$750 Fundraising milestone reached** = 1 additional entry
 - \$1,500 Fundraising milestone reached** = 1 additional entry
- Fundraising totals are **cumulative across the Promotion Period**.
- **Entries are capped at a maximum of four (4)**. Each fundraising milestone may only be achieved once per entrant during the Promotion Period.
- For the avoidance of doubt:
 - An entrant who has raised **\$0** in donations prior to the promotional period and raises **\$760** during the Promotion Period will receive **three (3) entries for reaching the \$150, \$500 and \$750 fundraising milestones**.
 - An entrant who has raised \$100 in donations prior to the promotional period and raise **\$1,500 or more** during the Promotion Period will receive **four (4) entries for reaching all the fundraising milestones**.

1. Entry into the International Women's Day Fun Run 2026 (IWDFR) ***Fit to Fab* promotion** ("Promotion") is deemed to be an acceptance of these Conditions of Entry. Information on how to enter the Promotion and prizes associated with the Promotion form part of these Conditions of Entry.
2. Entries for the Promotion commence at **00:01 AEST on Monday, 23 February 2026** and ends at **23:59 AEST on Sunday, 1 March 2026** ("Promotion Period").

3. Entry is open to all IWDFR participants ("**Entrants**") residing in Queensland, and over the age of 18 years on Sunday 1 March 2026.
4. Directors, officers, management, employees and other staff (and the immediate families of directors, officers, management, employees and other staff) of Mater Foundation and their related bodies corporate and agents are ineligible to enter.
5. Entries are deemed to be received upon a verified donation being received to a participant's fundraising page at www.womensdayfunrun.com.au during the promotion period where the total number of donations qualifies them to reach the next higher fundraising milestone.

- 16.2. The Prize cannot be transferred, exchanged or redeemed for cash.
